2003 Project: Lakeview Street, Interlaken

Just before Christmas the affiliate purchased a large lot on Lakeview Street in Interlaken.

Purchased with money from the SHOP grant we received last year, the lot is large enough that it may be split so that a second house could be built there in the future. That decision will depend on what's found when the lot, which is brush-covered now, is cleared to prepare for construction.

The Family Selection Committee has begun planning for this year's selection process. It plans to conduct two public meetings this year (we've always done one before) in an effort to expose the Habitat program and the Interlaken opportunity to as many people as possible.

The two public sessions will be followed by an evening program which will allow those planning to apply to submit

their applications in person or have any questions about the application process answered.

Visits to the homes of the applicants will follow the application submission

deadline.

A new group of new volunteers from Interlaken, Ovid and Lodi have joined the Family Selection Committee to help with this year's effort.

Meetings will be March 4 and 11

The first step in the process which will lead to the selection of a family for the home which will be built this year in Interlaken will begin with a pair of information meetings next month.

Families interested in applying to for the home on Lakeview Street in Interlaken can attend either of two meetings, at 7:30 p.m. on March 4 and March 11. The meetings will be in the Interlaken Reformed Church on Main Street in Interlaken, opposite the elementary school.

At the meeting families will learn about the family selection process and what's involved for the selected family as the house is built.

Habitat supporters can help the process by helping to spread the word about the meetings so we can let as many people as possible know about this opportunity.

Tyre house nearly done; landscaping still to come

The interior of the Black Brook Road house is now done, except for the installation of flooring.

Extensive landscaping remains to be done in the Spring. The formerly brush-covered lot had to have a well dug and a septic system installed and so the amount of work needed to create a lawn and a permanent driveway are more extensive than on our earlier projects.

With the weather this winter, there's been no opportunity to get a head start on the work.

The Partner Family, Patty Dishaw and her daughter, Stephanie and son, Daniel, are making progress on their sweat equity hours and the affiliate hopes we will be able to proceed to closing as soon as the landscaping is done.

Volunteers from the First Presbyterian Church in Seneca Falls helped put the mailing together; their efforts were part of the successful effort to cut costs.
